I the undersigned person, acting as the incorporator of a corporation under the provisions of the Washington Non-Profit Corporation Act (Revised Code of Washington 24.03), adopt the following articles of incorporation for such corporation:

ARTICLE ONE

The name of the corporation shall be the Gig Harbor High School Boosters Club.

ARTICLE TWO

This corporation shall exist is perpetuity.

ARTICLE THREE

This corporation is organized and operated exclusively for charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code. In doing so and to the extent that it is permitted to do so within the meaning of the immediately preceding sentence, this corporation shall support Gig Harbor High School athletic program on all levels to promote sportsmanship, loyalty and courage among all student athletes and shall take part in such other activities as may be provided by the by-laws and shall have such powers as are generally given to such organizations under Revised Code of Washington Chapter 24.03.

Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on (i) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code, or (ii) by a corporation to which contributions are deductible under Section 170(c)(2) of the Internal Revenue Code.

No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate or intervene in any political campaign (including the publishing or distribution of statements) on behalf of any candidate for public office.

ARTICLE FOUR

Membership in this corporation shall be obtained, and duties and responsibilities of the members of the corporation shall be, as set out in the by-laws of the corporation to be established.

ARTICLE FIVE
